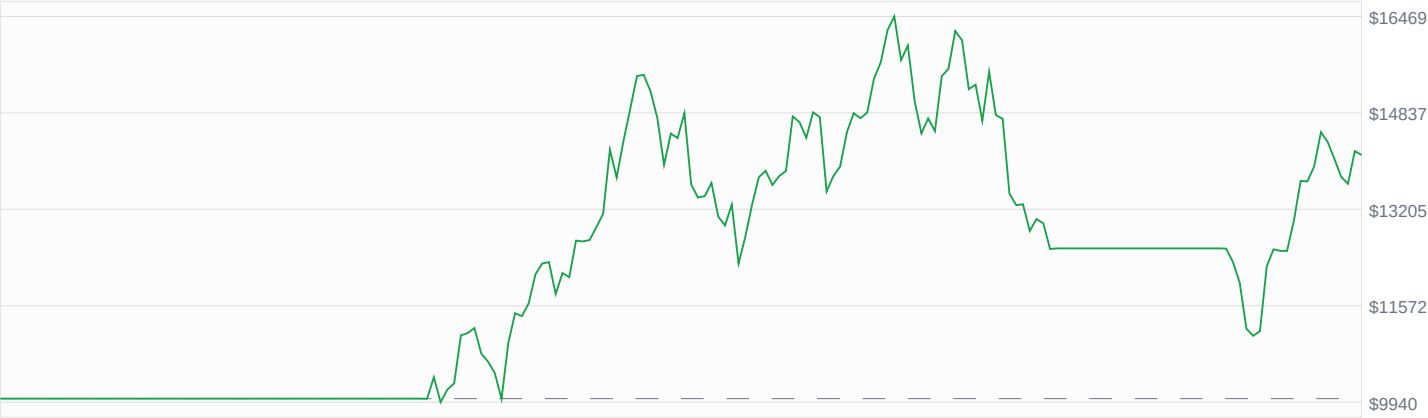

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v1989 strategy generated +41.20% ROI on SM with a perfect 100% win rate, driven by only two trades which creates statistically insignificant confidence in the Sharpe ratio of 1.21. A maximum drawdown of -32.83% reveals a severe lack of risk management despite the flawless win rate, suggesting overfitting to a specific market regime. The sample size is too small to validate robustness, making the final capital of \$14,124.38 a misleading indicator of performance. The next concrete step is to expand the backtest to five years of data and enforce hard stop-loss logic to filter out this extreme volatility risk.
