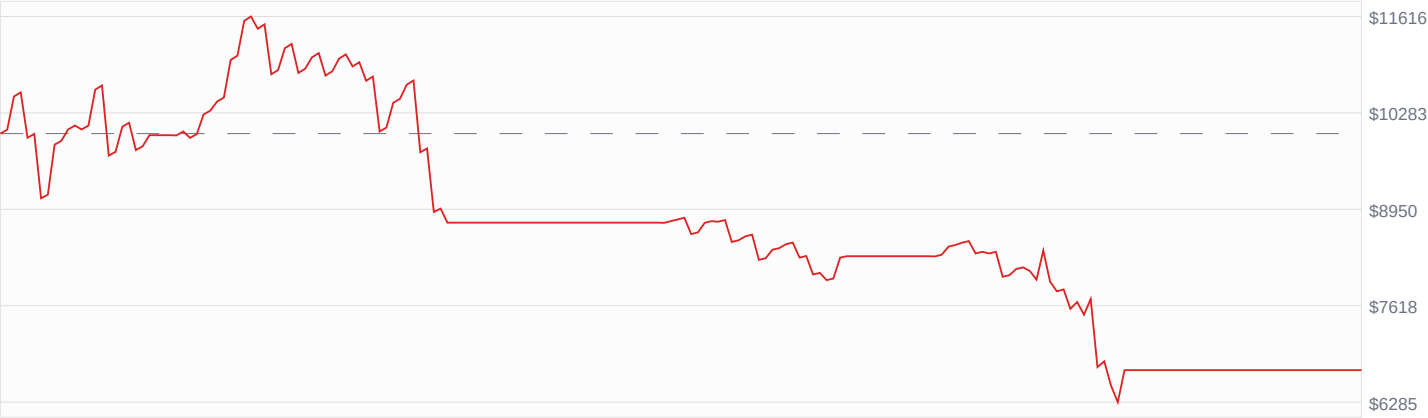

ANALYST NOTE

The strategy failed decisively, posting a negative thirty-two percent return with a zero percent win rate across four trades. A Sharpe ratio of negative one and a nearly forty-six percent drawdown indicate severe risk miscalibration rather than mere bad luck. The sample size is statistically insufficient to derive meaningful confidence, rendering the results anecdotal rather than predictive. The core signal logic appears fundamentally flawed for this asset class, likely triggering entries during adverse momentum. Immediate next step is to conduct a parameter sensitivity analysis to identify if the RSI thresholds are inverted or misaligned with VOXR volatility.
