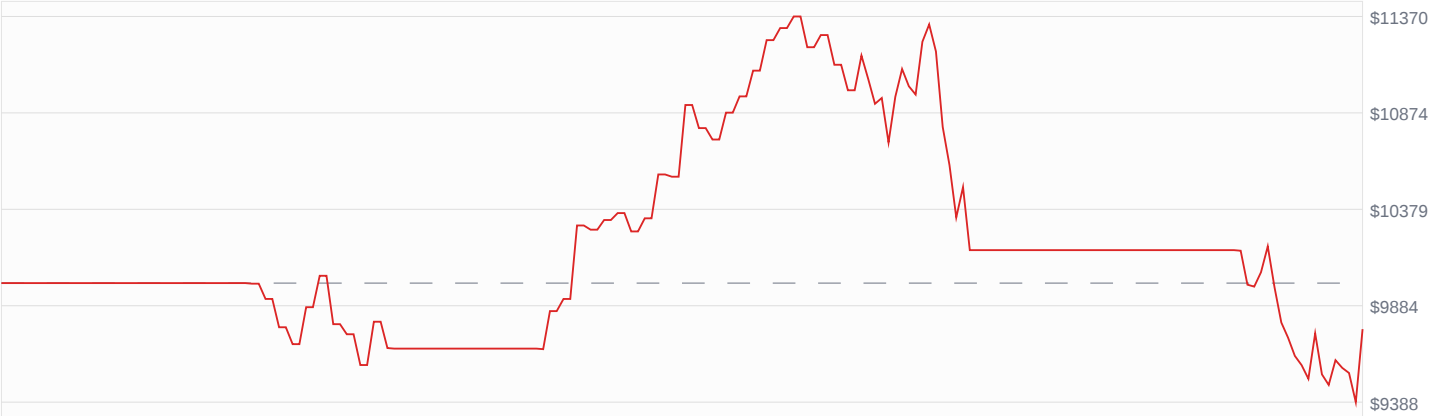

ANALYST NOTE

Hera local LLM

The strategy posted a negative ROI of -2.39% with a Sharpe ratio of -0.12, indicating poor risk-adjusted performance. A 33.3% win rate alongside a 17.43% max drawdown suggests the signal logic lacks sufficient edge to offset transaction costs and adverse price action. With only three total trades, the sample size is statistically negligible, making it impossible to distinguish genuine alpha from random variance. The current parameters likely overfit historical noise rather than capturing durable market structure. Implement a longer backtesting window with a minimum of one hundred trades to establish statistical validity before any further deployment.
