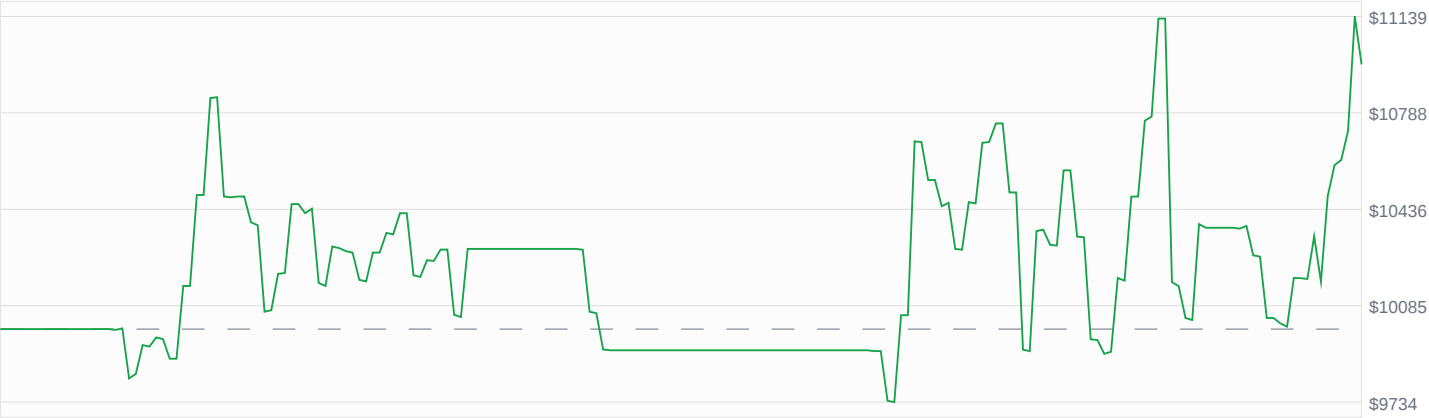

The +9.61% ROI and 60% win rate suggest the Zen Mean Reversion strategy captures short-term inefficiencies in SLDE. However, the 0.62 Sharpe ratio is below institutional standards, indicating mediocre risk-adjusted performance relative to the volatility endured. The 10.08% max drawdown is manageable, but the primary flaw is the tiny sample of five trades, which renders the statistical confidence negligible and likely driven by luck rather than edge. Without a larger dataset, you cannot distinguish a genuine alpha signal from random noise. The next step is to extend the backtest period to at least fifty trades to establish statistical significance before considering live deployment.
