ANALYST NOTE

The EVO_EVOEVOEVOE_v2172 strategy on ASC generated an 18.35% return, yet the sample size of only three trades renders the 66.7% win rate statistically insignificant and untrustworthy. A Sharpe ratio of 0.82 indicates moderate risk-adjusted performance, but a maximum drawdown of 17.18% exposes significant volatility that the small trade count fails to mitigate. The results suggest the parameters may be overfitting to recent noise rather than capturing a robust market edge. We must expand the sample size by running a forward walk-forward analysis or increasing the trade frequency threshold to validate consistency. Until the strategy produces a statistically significant dataset, we cannot confirm its viability for live deployment.
