The EVO_EVOEVOE_v2266 strategy on BWB yielded a positive 12.63% ROI but generated only two trades, rendering the 1.03 Sharpe ratio statistically insignificant due to severe sample size constraints. A 50% win rate with a 9.20% maximum drawdown suggests the logic lacks robustness under current volatility, as the edge cannot be validated without more frequent data points. We must expand the parameter space or switch to a higher-frequency interval to accumulate enough trades for a meaningful confidence interval before deploying live capital. Future iterations should prioritize trade frequency over marginal capital growth to ensure the strategy survives regime shifts.
