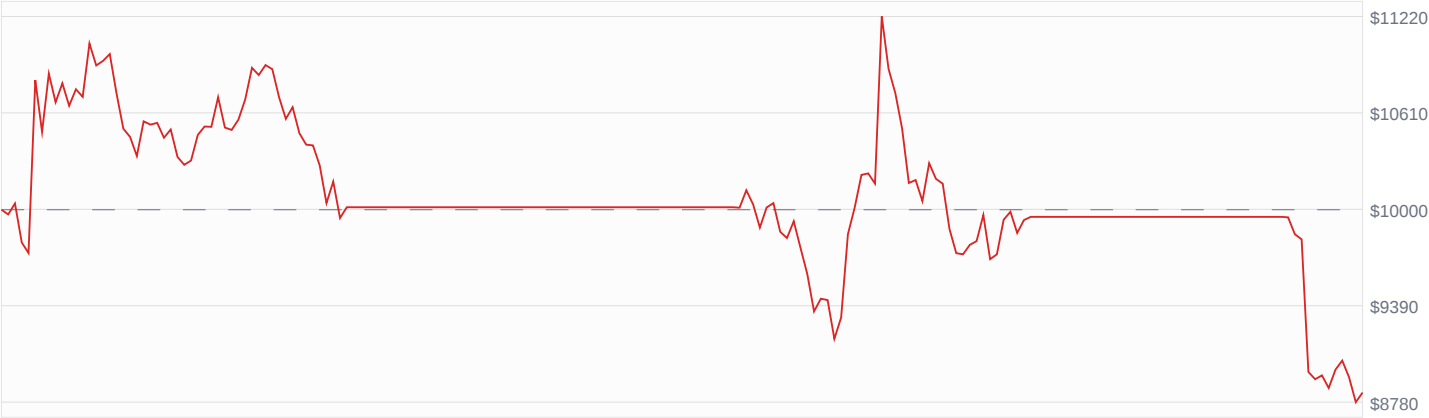

ANALYST NOTE

Hera local LLM

The strategy failed decisively, losing 11.62% with a negative Sharpe ratio of -0.45 and a 33.3% win rate. The 21.75% maximum drawdown indicates poor risk management during adverse price action. Statistical confidence is negligible due to the extremely small sample size of only three trades. The edge is absent, requiring a fundamental redesign of the entry logic. Next, expand the backtest window to at least one hundred trades to establish a valid baseline.
