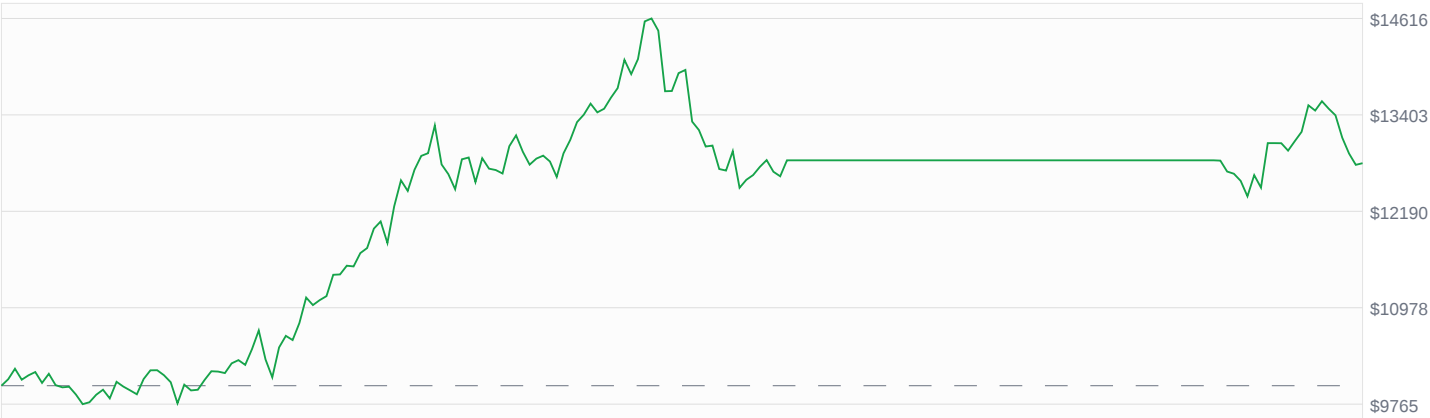

The +27.92% ROI and 1.53 Sharpe ratio look strong on the surface, but they are statistically meaningless with only two trades. A 50% win rate combined with a 15.30% max drawdown indicates the strategy lacks consistent edge and suffers from high volatility relative to its returns. You cannot trust any performance metric derived from such a tiny sample size because it fails to capture market cycles or strategy decay. Run this strategy back over at least five years of data to establish a statistically significant baseline before considering it viable.
