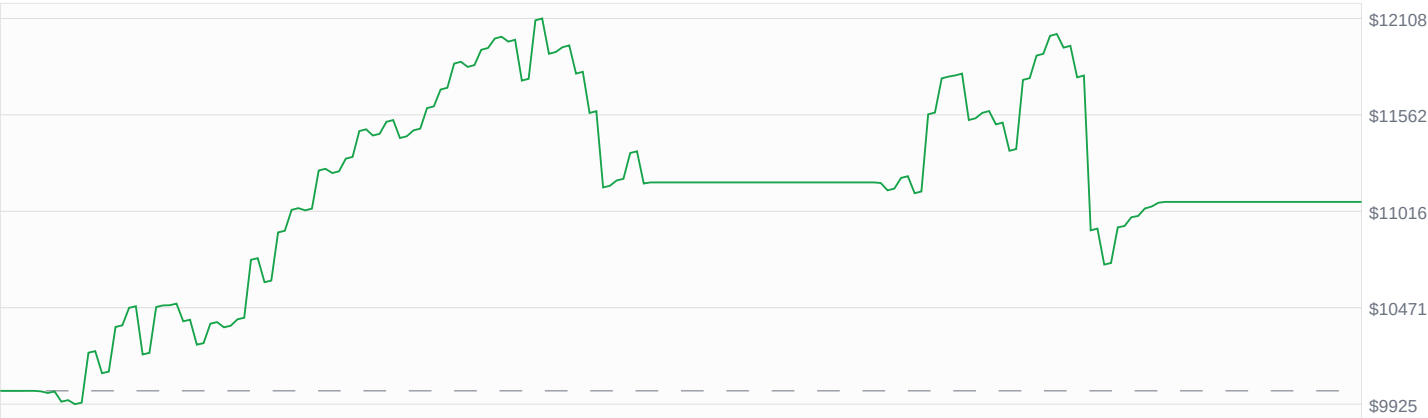

The EVO_WEBIDEA_v2162 strategy on AAPL generated a nominal 10.70% return, but a sample size of only two trades renders the Sharpe ratio of 0.87 statistically insignificant and untrustworthy. A 50% win rate with an 11.50% maximum drawdown suggests the system lacks robustness and is highly vulnerable to regime changes. Without more data points, we cannot confirm if the alpha is genuine or merely a lucky outlier in a specific market environment. We must immediately run a new backtest with adjusted parameters or a longer lookback period to validate performance before live deployment. This approach ensures we distinguish between strategy efficacy and random noise in our capital allocation process.
