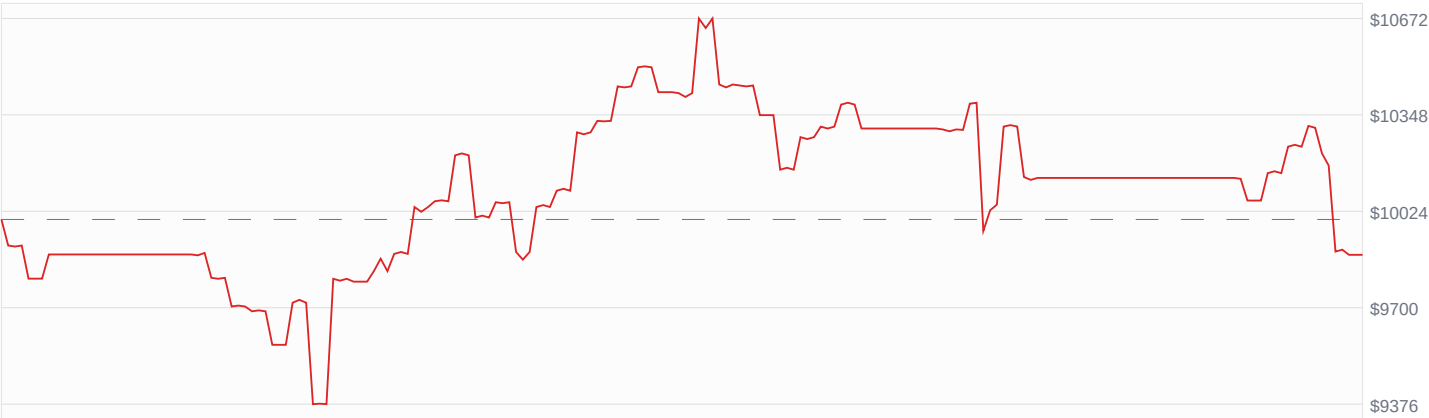

ANALYST NOTE

The Zen Mean Reversion strategy on HAFC failed to generate alpha, delivering a negative ROI of -1.22% and a Sharpe ratio of -0.06 across only four trades. The 25.0% win rate and 7.44% maximum drawdown indicate the mean reversion logic is misaligned with current volatility, likely triggering premature exits. With such a minimal sample size, these metrics lack statistical significance and cannot reliably predict future performance. We must verify whether the underlying asset has shifted from its historical mean-reverting regime before redeploying capital.
