The 100% win rate on SM is statistically meaningless with only two trades, offering zero confidence in the strategy's robustness. While the 41.20% ROI and 1.21 Sharpe ratio look strong, they are artifacts of a tiny sample and the 32.83% max drawdown reveals significant downside risk that the small trade count masks. This backtest fails to demonstrate consistent edge or proper risk management across market cycles. You must extend the simulation to at least fifty trades across varying volatility regimes before considering deployment.
