This strategy lacks statistical confidence due to only three total trades, rendering the 6.75% ROI and 0.54 Sharpe ratio insignificant for institutional evaluation. The 33.3% win rate combined with a 15.79% max drawdown indicates poor risk management where losses outweigh frequent small gains. The high drawdown relative to return suggests the entry logic fails to filter out adverse volatility effectively. You must extend the backtest period to at least one hundred trades to establish a valid baseline. This will reveal if the positive expectancy is structural or merely noise from a tiny sample.
