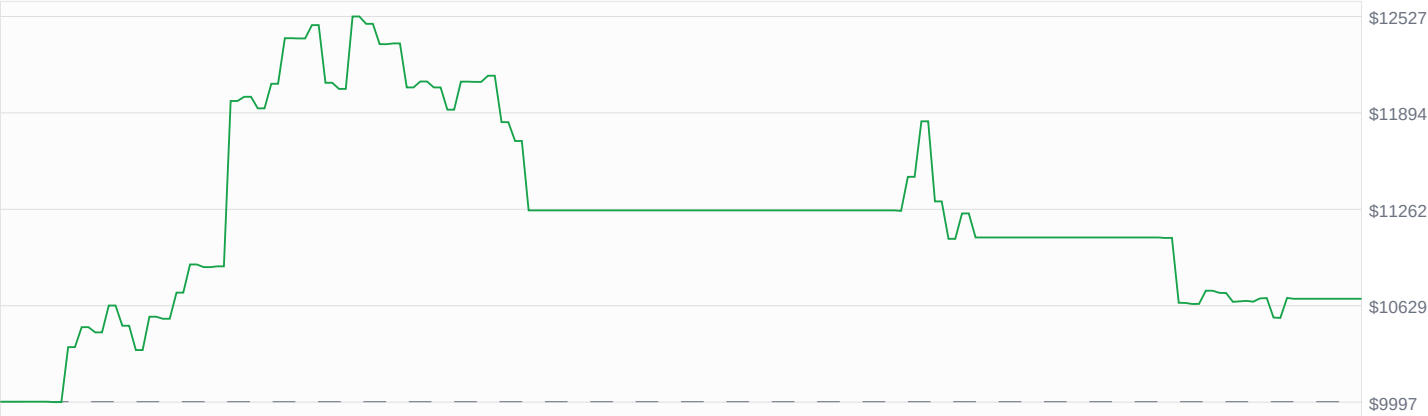

ANALYST NOTE

Hera local LLM

The EVO_WEBIDEA_v50 backtest on GOOGL shows limited statistical significance with only three trades, rendering the 6.75% ROI and 0.54 Sharpe ratio unreliable. A mere 33.3% win rate paired with a 15.79% drawdown indicates high volatility and insufficient edge for institutional deployment. The strategy lacks robustness due to the tiny sample size, making any performance metrics prone to overfitting or random noise. Next, extend the backtest period and optimize entry thresholds to validate whether the signals hold across different market regimes before live allocation.
