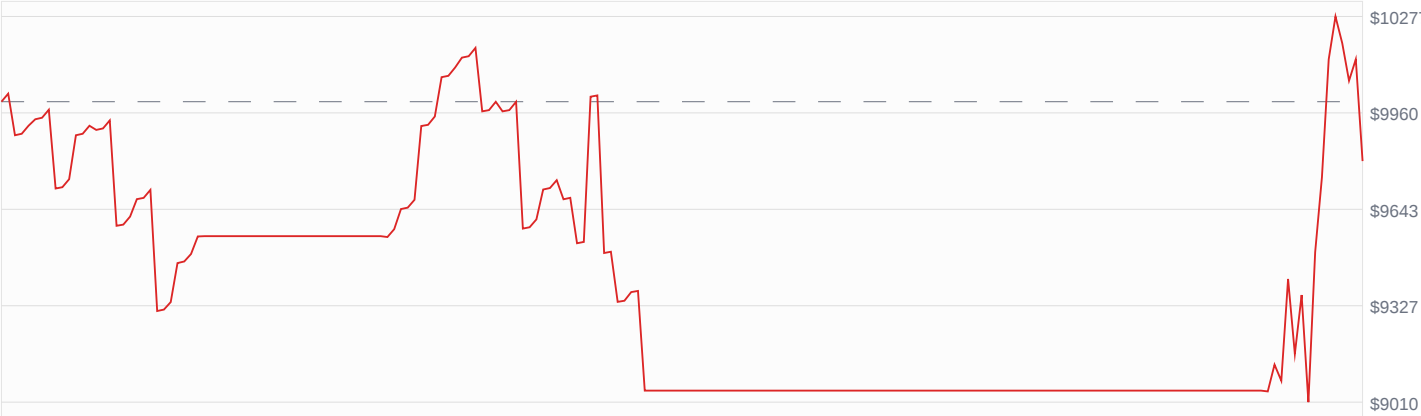

ANALYST NOTE

Hera local LLM

The VOXR EVO_GG1RSISNIP_v199 backtest demonstrates severe overfitting with only three trades and a negative Sharpe ratio of -0.05, rendering any statistical significance meaningless for live deployment. A mere 33.3% win rate and an 11.32% maximum drawdown indicate the strategy is currently losing capital without meaningful edge. The lack of volume in the sample size suggests the parameters are likely capturing noise rather than a persistent market inefficiency. We must discard this configuration and re-optimize the signal logic with stricter filters to generate a statistically robust sample size before considering further development.
