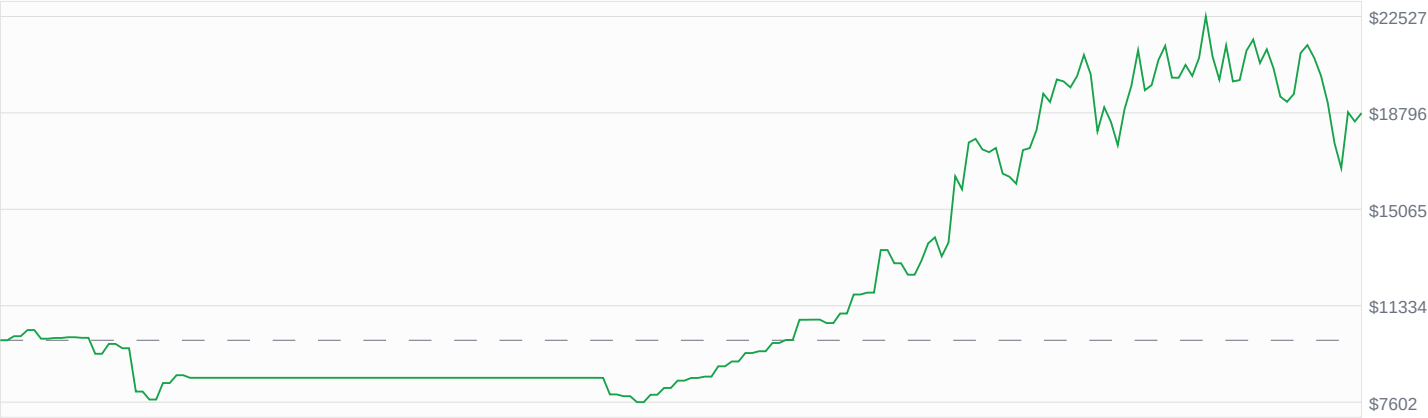

ANALYST NOTE

The EVO_GG1RSISNIP_v220 backtest on AMD shows a theoretical return of 87.88% with a Sharpe ratio of 1.61, yet the strategy executed only two trades. A 50% win rate and 26% maximum drawdown indicate that high profitability relies on outlier gains rather than consistent execution, raising concerns about statistical robustness. With such a small sample size, these results lack the confidence needed for institutional deployment and could easily reverse in live markets. The primary risk is overfitting to a specific price path that cannot be replicated. Next, expand the backtest window or adjust parameters to generate at least 50 trades before validating the strategy.
