The EVO_GG1RSISNIP_v467 backtest on AMZN reveals severe underperformance with a negative ROI of -2.39% and a Sharpe ratio of -0.12, indicating a strategy that lost money relative to risk-free assets. The extremely low total trade count of three and a win rate of merely 33.3% provide insufficient statistical power to validate the approach or rule out random noise. A maximum drawdown of 17.43% suggests aggressive risk exposure that failed during this specific market regime, rendering the results statistically insignificant at standard confidence levels. The primary failure mode appears to be poor entry timing or excessive volatility, as the final capital of \$9,763.47 reflects a net loss from the initial position. The immediate next step is
