ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOG_v1661 strategy on MSFT delivered a nominal +23.06% return and a Sharpe of 1.19, yet the sample size of only two trades renders these metrics statistically insignificant. A 50% win rate provides no directional edge, and a 14.24% drawdown suggests high volatility relative to the minimal trade frequency. We must expand the lookback window or adjust entry filters to generate sufficient trade volume for robust validation before deploying live capital. The next step is to run a walk-forward analysis to test parameter stability across different market regimes.
