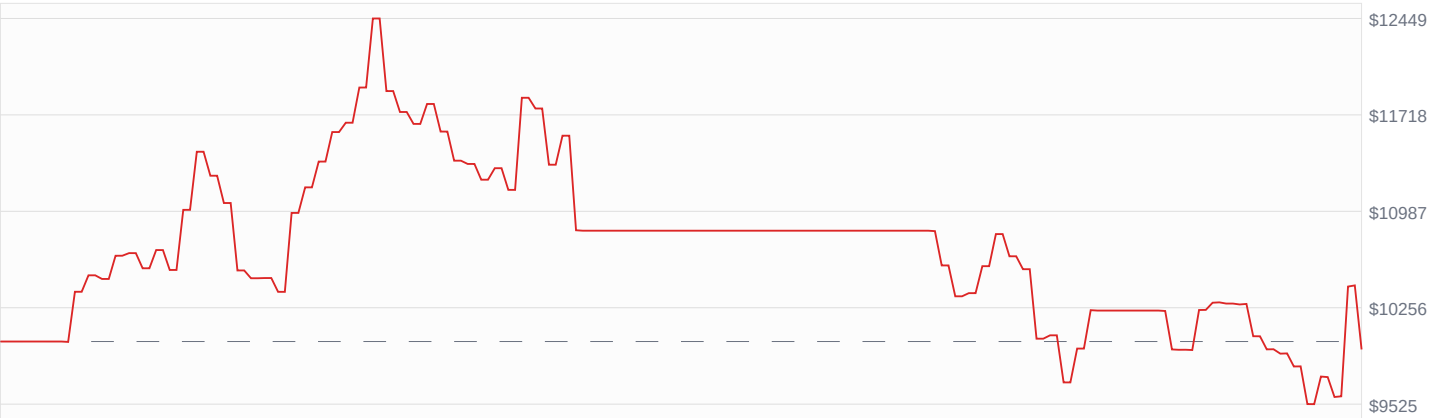

ANALYST NOTE

Hera local LLM

The EVO_EVOWEBIDEA_v418 strategy on NVDA failed to capture value, delivering a marginal -0.63% return with a Sharpe ratio of 0.09, indicating poor risk-adjusted performance. A win rate of 33.3% and a maximum drawdown of 23.49% suggest the entry logic is overly aggressive given the minimal three-trade sample size. With only three executed trades, the statistical confidence is negligible, making any conclusion about strategy robustness premature. The data indicates a need to tighten entry filters or extend the backtest horizon to validate signal reliability. Re-running the simulation with a wider date range is the immediate next step to gather sufficient data points.
