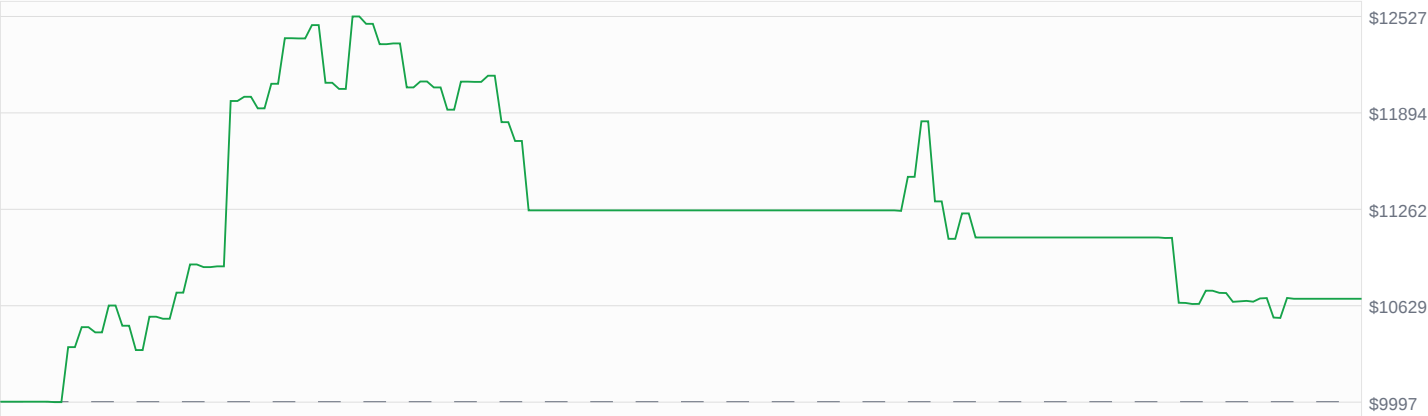

The EVO_EVOEVOE_v797 backtest on GOOGL shows a modest 6.75% return with a 33.3% win rate, yet the sample size of only three trades renders these metrics statistically insignificant and prone to overfitting. The 0.54 Sharpe ratio suggests marginal risk-adjusted performance while the 15.79% maximum drawdown indicates high volatility exposure relative to the small trade frequency. Without more data points, we cannot confidently attribute this outcome to strategy edge rather than random market noise. We must expand the test period or adjust parameters to generate sufficient trade volume for reliable validation. The immediate priority is running a walk-forward analysis to ensure robustness before deployment.
