The strategy delivered a 41.20% return on SM with a perfect 100% win rate, yet this sample of just two trades provides insufficient statistical confidence to validate the robustness of the 1.21 Sharpe ratio. The 32.83% maximum drawdown highlights significant volatility risk that contradicts the apparent stability suggested by the high win rate. Such a low trade count often indicates overfitting to historical noise rather than capturing sustainable market edges. We must immediately expand the backtest timeframe and test alternative parameter sets to verify performance consistency before live deployment.
