The EVO_EVOEVOEVOE_v856 strategy failed on RDN with a -5.59% ROI and zero winning trades, driven by a 14.78% drawdown across only three executions. A Sharpe ratio of -0.31 indicates severe risk-asset imbalance rather than alpha generation, and the tiny sample size renders statistical inference impossible. The complete lack of profitable outcomes suggests the entry logic is fundamentally misaligned with current volatility regimes. Before reallocation, we must retest with tightened stop-losses and a broader parameter sweep to confirm if this is a regime break or a flawed design.
