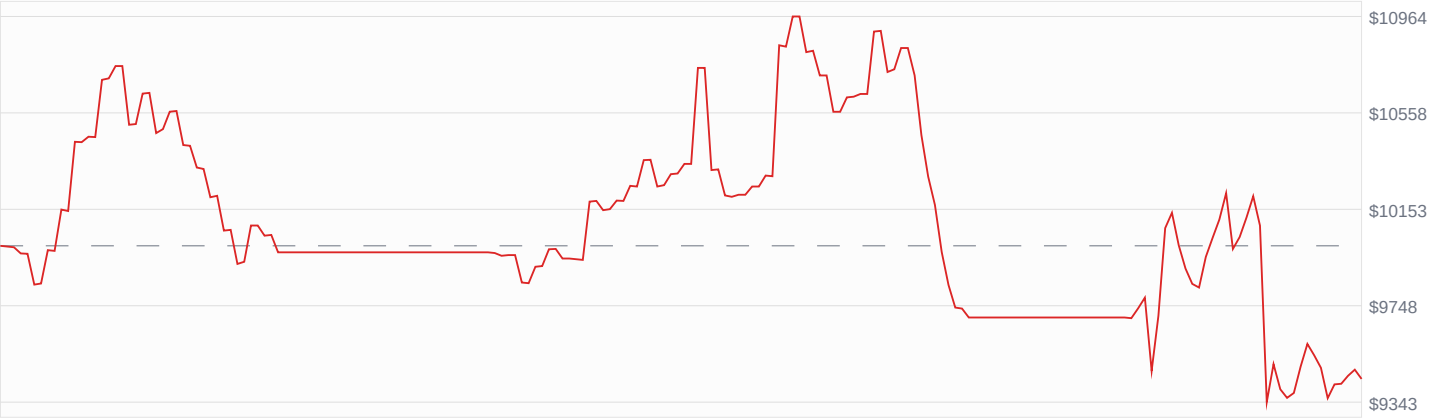

The EVO_EVOEVOEVOE_v707 strategy failed on RDN with a -5.59% ROI and zero winning trades, indicating the logic is fundamentally misaligned with current market structure. A 14.78% drawdown across only three trades reveals insufficient statistical significance to draw robust conclusions, making the Sharpe ratio of -0.31 a non-predictive metric rather than a true measure of risk-adjusted performance. The near-zero win rate suggests the entry triggers are catching the asset in a persistent downtrend where momentum indicators consistently fail. We must immediately expand the sample size by running a broader parameter sweep across different volatility regimes before deeming the approach unviable.
