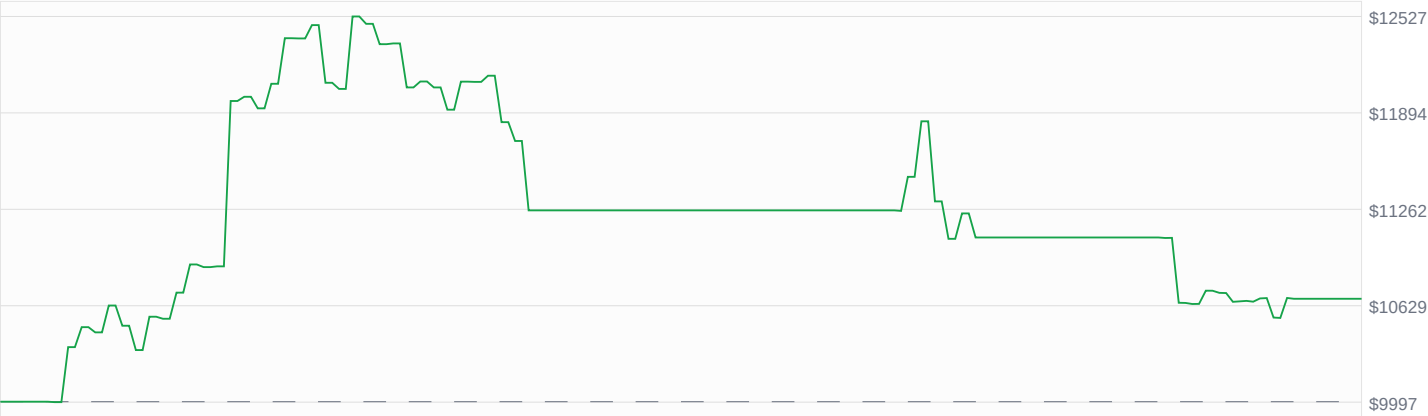

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v731 strategy generated a nominal 6.75% return on GOOGL with a 33.3% win rate, yet the low trade count of three transactions renders the Sharpe ratio of 0.54 statistically insignificant. A maximum drawdown of 15.79% indicates high volatility risk that is not adequately captured by such a limited sample size. The strategy failed to produce consistent directional bias, suggesting the entry logic requires refinement or a longer equity curve to validate performance. We must expand the test period or adjust parameters to increase trade frequency before considering deployment.
