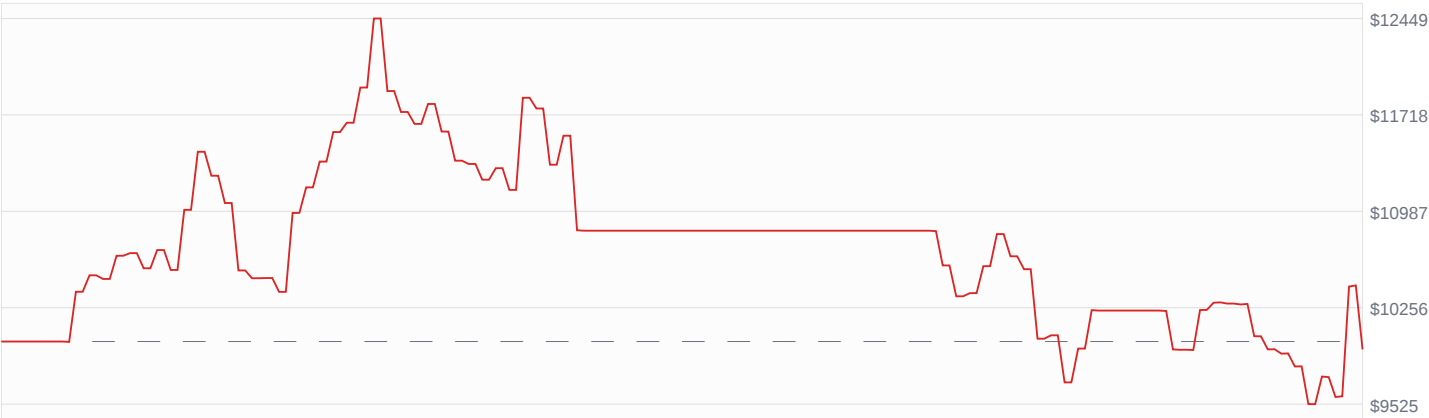

ANALYST NOTE

The EVO_GG1RSISNIP_v917 backtest on NVDA is statistically insignificant, yielding only three trades with a negative ROI of 0.63% and a dangerously low win rate of 33.3%. The strategy suffered a 23.49% maximum drawdown while generating a Sharpe ratio of 0.09, indicating poor risk-adjusted returns and likely overfitting to noise. Without sufficient trade volume, the results lack any meaningful statistical confidence to justify live deployment. To validate the logic, I will expand the test period to capture at least 100 trades and refine the entry filters.
