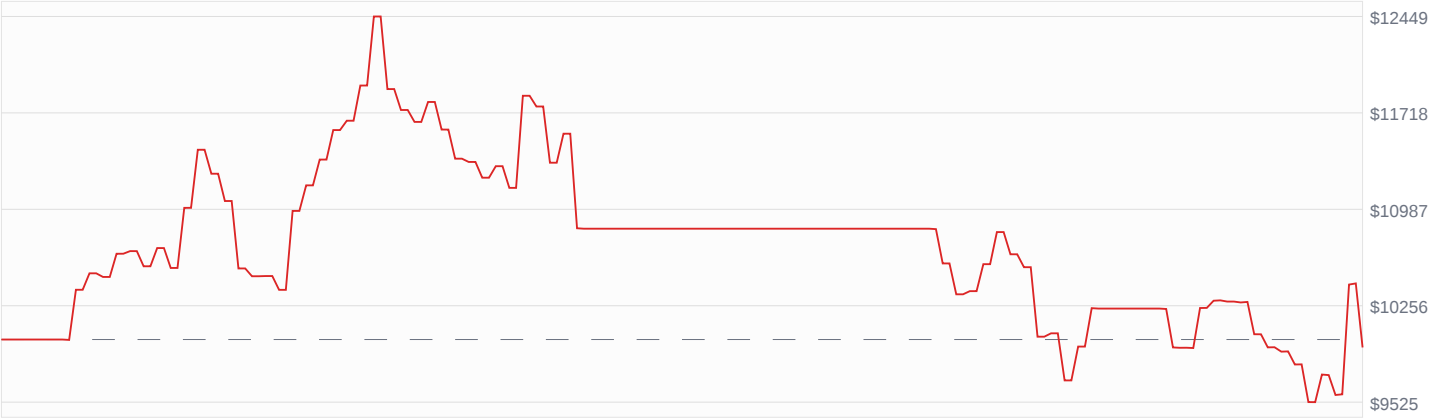

ANALYST NOTE

The EVO_GG1RSISNIP_v1625 strategy on NVDA failed with a -0.63% ROI and a meager 0.09 Sharpe ratio, indicating no risk-adjusted alpha. A mere 33.3% win rate across just three trades is statistically insignificant, rendering the -23.49% drawdown a dangerous outlier rather than a trend. This sample size provides zero confidence for institutional deployment or generalization to other market regimes. Immediate next step is to recalibrate entry filters or expand the lookback period to generate sufficient trade volume for robust validation.
