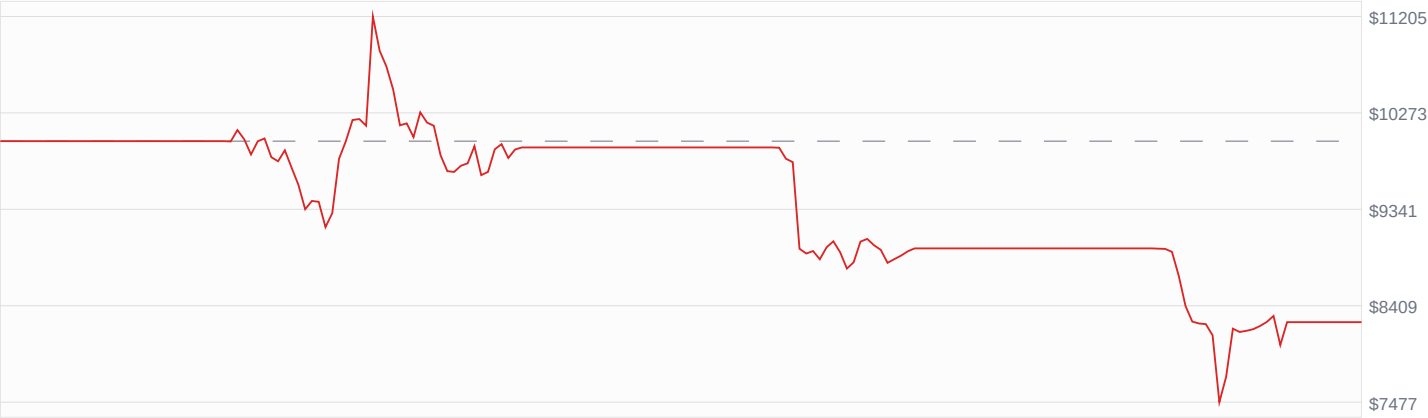

The EVO_GG1RSISNIP_v942 strategy on META failed catastrophically, yielding a -17.5% ROI and zero winning trades over a sample of only three executions. A 33.28% drawdown paired with a negative Sharpe ratio indicates severe risk exposure, likely stemming from an inability to filter false breakouts or manage stop-losses effectively. With such a minuscule sample size, the statistical significance is negligible, rendering any performance metrics unreliable indicators of future viability. Immediate parameter optimization is required to address the specific failure mode that triggered these exits, but no live deployment should occur until the strategy demonstrates robustness on a larger dataset.
