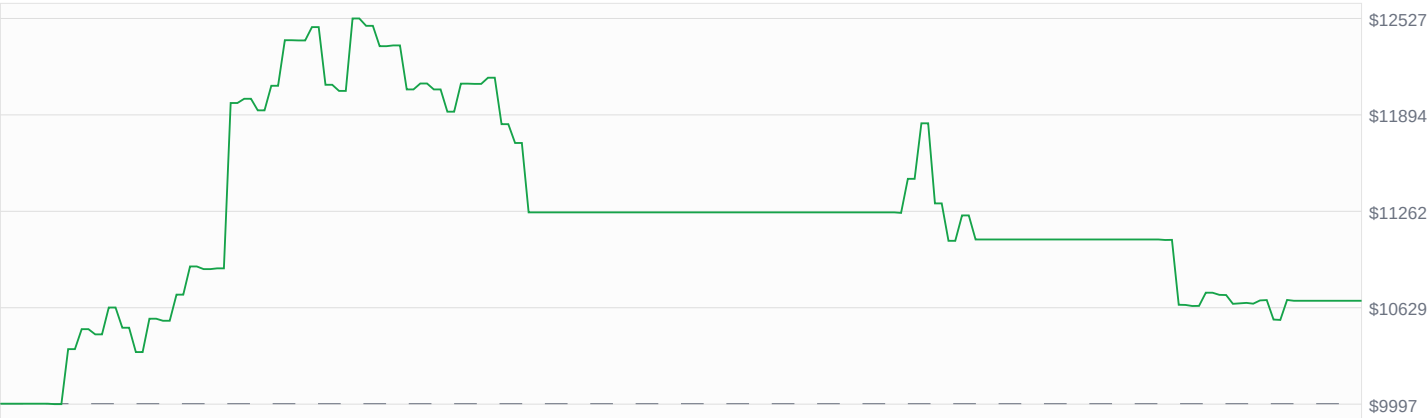

ANALYST NOTE

The EVO_WEBIDEA_v943 backtest on GOOGL delivered a +6.75% ROI with a 33.3% win rate, yet the sample size of three trades renders statistical confidence negligible. A Sharpe ratio of 0.54 indicates weak risk-adjusted returns, while a 15.79% maximum drawdown exposes the capital to significant volatility without sufficient reward compensation. The strategy clearly failed to generate consistent alpha, likely due to overfitting on a limited historical window. We must expand the test dataset to at least one hundred trades and recalibrate stop-loss logic before considering live deployment.
