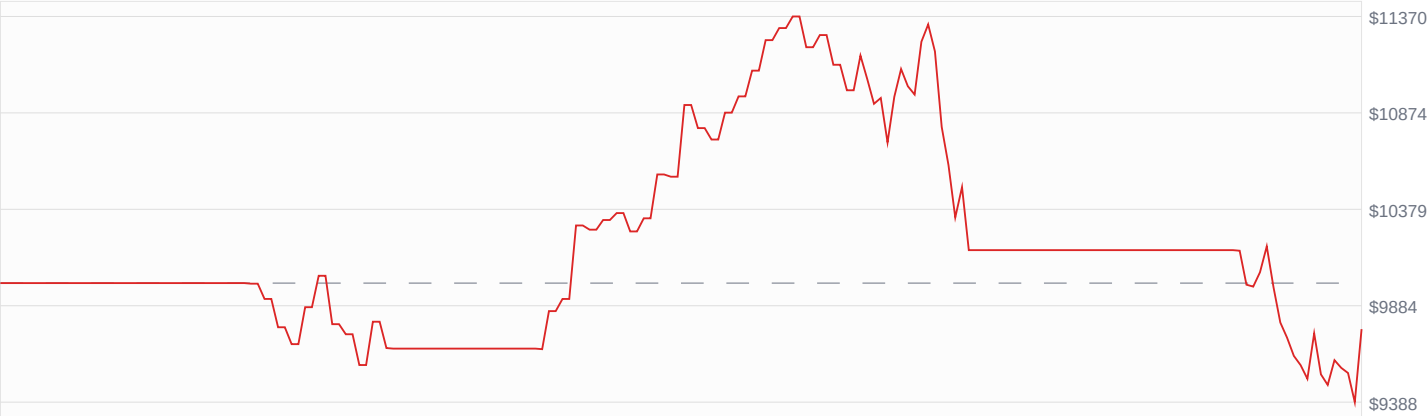

The EVO_GG1RSISNIP_v1628 strategy on AMZN failed decisively with a negative ROI of -2.39% and a Sharpe ratio of -0.12, indicating poor risk-adjusted returns. With only three trades executed, the statistical sample is insufficient to draw any meaningful conclusions about the strategy's robustness or edge. The maximum drawdown of 17.43% suggests the position sizing or stop-loss logic requires immediate recalibration to prevent significant capital erosion. Re-running the backtest with expanded historical data is the necessary next step to validate whether this underperformance is an anomaly or a systemic flaw.
