The EVO_GG1RSISNIP_v1064 strategy on VOXR failed decisively, delivering a -2.01% return with a negative Sharpe ratio of -0.05. Only three executed trades generated a 33.3% win rate, which is statistically insignificant given the minimal sample size. The strategy suffered an 11.32% maximum drawdown, indicating poor risk control during adverse market conditions. With final capital reduced to \$9,801.86, the approach lacks the robustness required for institutional deployment. The immediate next step is to expand the historical test window or restructure the signal logic to improve trade frequency and consistency.
