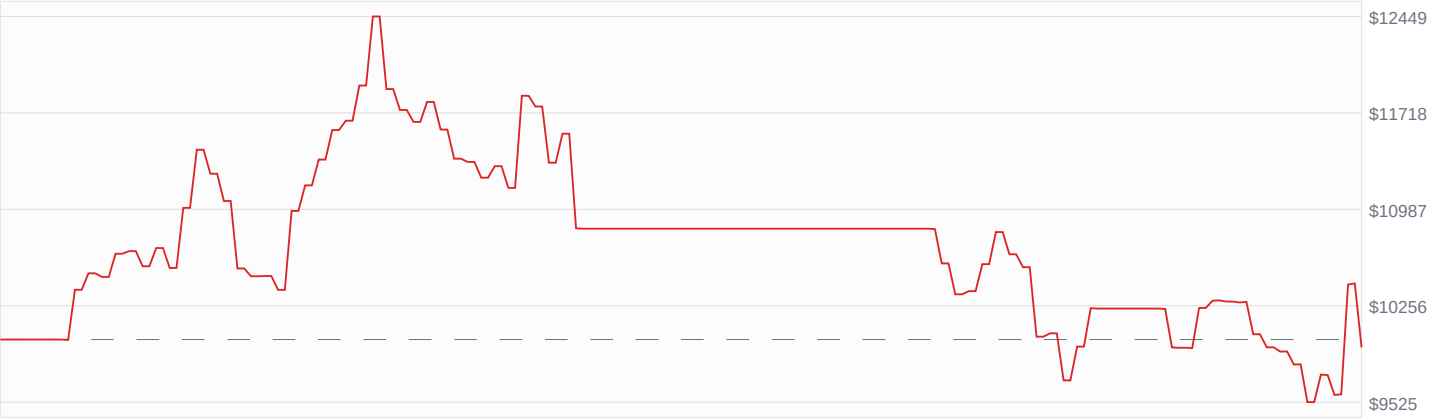

The EVO_GG1RSISNIP_v1081 backtest on NVDA yielded a negative return of 0.63% with a meager Sharpe ratio of 0.09, indicating a strategy lacking risk-adjusted performance. A win rate of only 33.3% and a maximum drawdown of 23.49% suggest the signal logic failed to capture meaningful upside while exposing capital to substantial downside. With merely three trades executed, the statistical sample is too small to draw firm conclusions or validate the robustness of the entry triggers. The lack of conviction in the signals warrants an immediate review of the indicator thresholds to filter out low-probability false positives. We must expand the sample size through parameter optimization before deploying any live capital.
