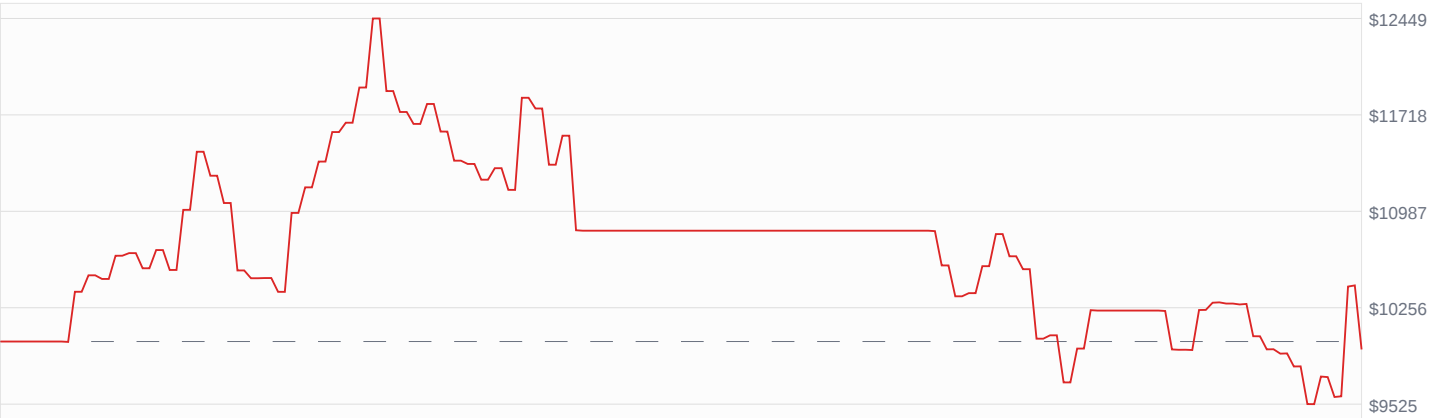

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v1113 strategy on NVDA failed catastrophically, generating a -0.63% ROI and a 23.49% max drawdown across only three trades. A win rate of 33.3% and a Sharpe ratio of 0.09 indicate severe underperformance with negligible statistical confidence due to the extremely low sample size. This result suggests the current signal logic lacks robustness for high-beta semiconductor volatility. The immediate next step is to expand the backtest window to hundreds of trades to validate edge or confirm total irrelevance.
