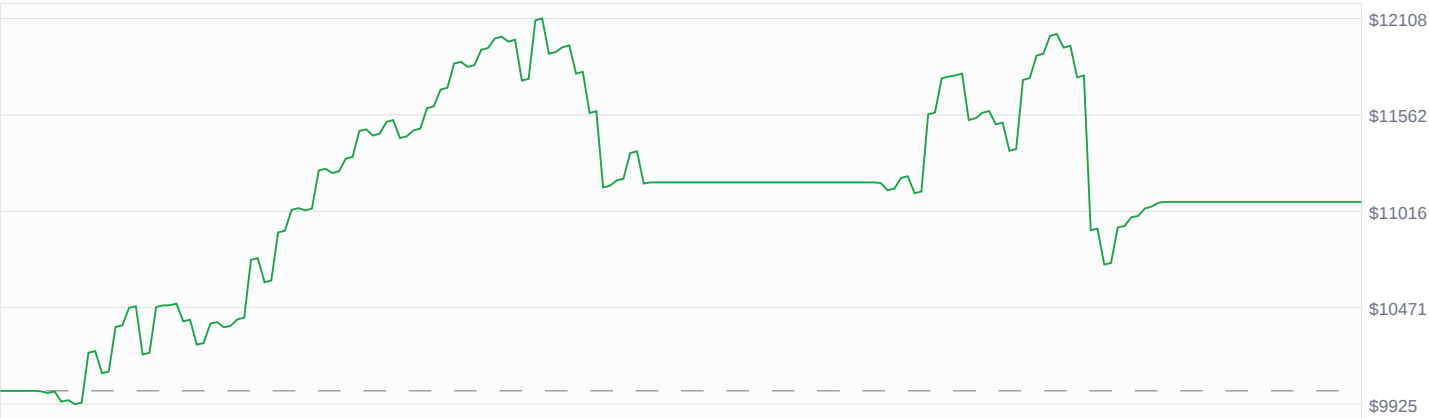

ANALYST NOTE

Hera local LLM

The +10.70% ROI masks severe statistical unreliability, as a sample of only two trades provides zero confidence in the 50% win rate. A Sharpe ratio of 0.87 is mediocre and meaningless with such a tiny dataset, while the 11.5% drawdown indicates high volatility relative to the returns. The strategy failed to demonstrate consistent edge or risk control over a meaningful period. Extend the backtest to at least two hundred trades across multiple market regimes to validate the signal before deploying capital.
