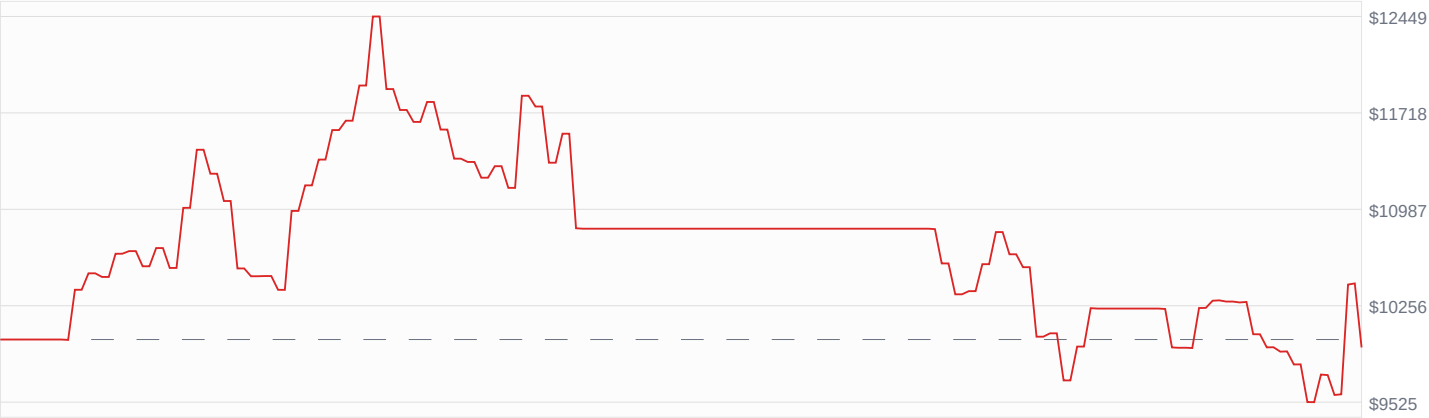

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v332 backtest on NVDA reveals a statistically insignificant failure due to a mere three trades, rendering the 33.3% win rate and 0.09 Sharpe ratio unreliable noise. The strategy generated a marginal -0.63% ROI while suffering a 23.49% maximum drawdown, indicating poor risk control during the simulated period. With such a small sample size, the results lack the confidence required for institutional deployment or performance attribution. The next concrete step is to expand the lookback period or adjust entry filters to generate sufficient trade frequency for a robust statistical analysis.
