The EVO_GG1RSISNIP_v278 strategy on BWB generated a marginal +2.15% return with a negligible Sharpe of 0.25, indicating the profit likely stems from noise rather than a robust edge. A 33.3% win rate across only three trades is statistically insignificant and fails to account for transaction costs in live execution. The 13.41% maximum drawdown suggests high volatility sensitivity that requires further filtering before deployment. We must increase the simulation horizon and trade frequency to validate statistical significance before considering any live allocation.
