The EVO_EVOEVOE_v789 strategy generated a 41.20% ROI with a perfect win rate on only two trades for SM, but a 32.83% maximum drawdown reveals extreme tail risk. With such a small sample size, the 1.21 Sharpe ratio lacks statistical significance and does not confirm robust edge. The flawless win rate likely reflects a survivorship bias rather than a sustainable alpha. You must validate this logic by expanding the backtest horizon and increasing trade frequency to assess true volatility.
