The EVO_GG1RSISNIP_v84 backtest on AAPL shows a +10.70% ROI but suffers from severe statistical unreliability due to only two executed trades. A 50% win rate and 0.87 Sharpe ratio provide no meaningful confidence in the strategy's edge over random noise. The 11.50% maximum drawdown suggests significant volatility risk that is impossible to assess with such a thin sample size. I recommend expanding the backtest lookback period or adjusting entry parameters to generate a statistically significant dataset before deployment.
