The strategy generated positive returns on Microsoft, yet the sample size of only two trades renders the 23.06% ROI statistically insignificant and unreliable. A 50% win rate combined with a 14.24% maximum drawdown suggests high volatility without a clear edge, making the Sharpe ratio of 1.19 less meaningful. We must expand the data window to validate whether the signal logic holds across diverse market conditions before deployment. Running a new backtest with a longer historical dataset is the necessary next step to confirm robustness.
