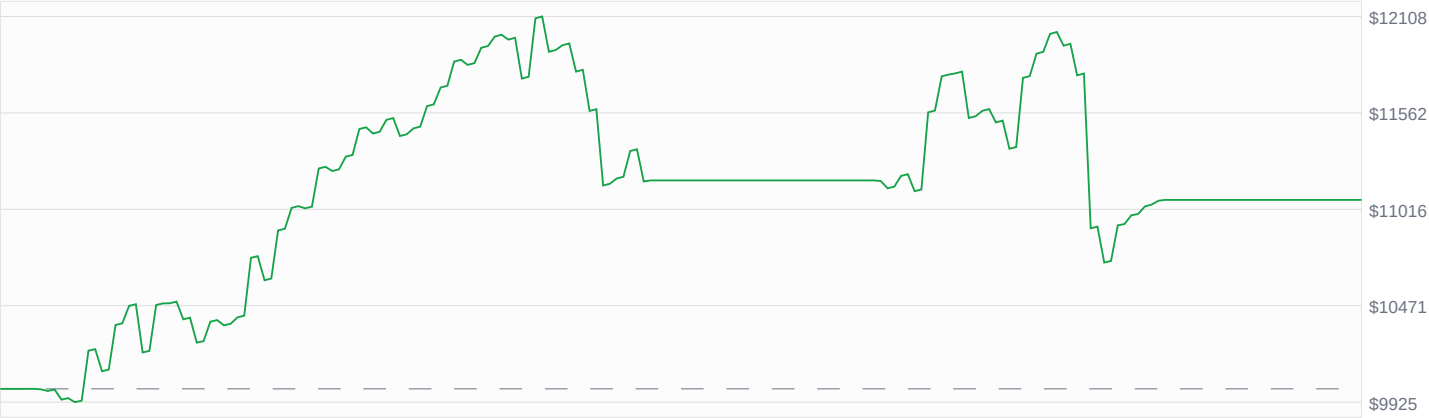

The EVO_EVOEVOEVOE_v1956 backtest on AAPL yielded a 10.7% return, yet the statistical significance is negligible due to only two trades. A 50% win rate with a 1.5-year data horizon provides no confidence that the strategy captures alpha rather than random noise. The 11.5% maximum drawdown indicates substantial risk exposure relative to the modest Sharpe ratio of 0.87. Immediate next steps require expanding the sample size by testing on related tech names to validate robustness. Until statistical confidence improves, this configuration remains unactionable for live deployment.
