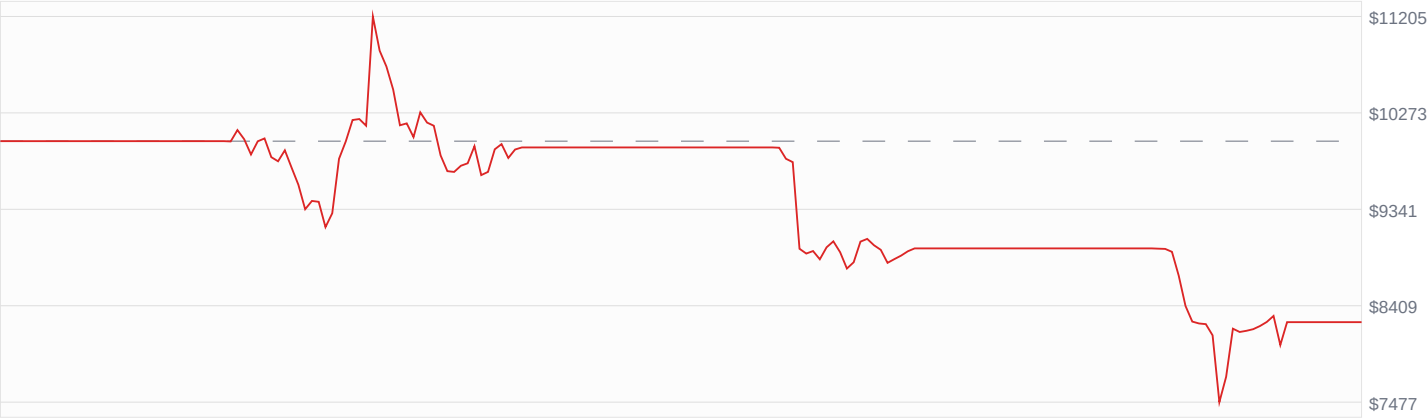

The EVO_GG1RSISNIP_v1299 strategy on META failed catastrophically with a -17.50% ROI and zero winning trades, driven by a single loss that triggered a 33.28% maximum drawdown. The sample size of only three trades renders the -0.85 Sharpe ratio statistically insignificant and unreliable for institutional decision-making. Such extreme volatility suggests the entry logic is fundamentally misaligned with current market microstructure or liquidity conditions. We must immediately pause deployment and re-examine the signal generation parameters against fresh OHLCV data. The next concrete step is to run a walk-forward analysis to identify if the failure is a temporary regime shift or a structural flaw in the strategy.
