ANALYST NOTE

Hera local LLM

The EVO_EVOEVOE_v1869 strategy on SM shows a 41.20% ROI with a perfect 100% win rate, but this success is statistically unreliable given only two trades. A 32.83% maximum drawdown indicates extreme volatility risk that the current sample size completely masks, rendering the 1.21 Sharpe ratio misleading. The strategy likely overfit to specific price action, creating a false sense of security for any live deployment. The immediate next step is to expand the backtest horizon and introduce walk-forward analysis to verify robustness against unseen market regimes.
