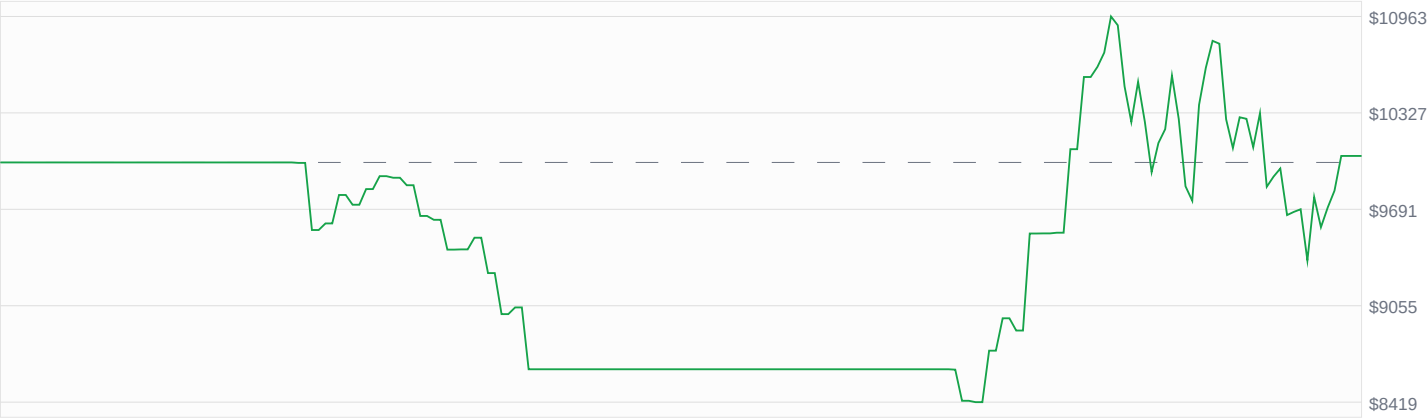

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v1339 backtest on PLMR yielded a mere +0.43% ROI with a razor-thin 50% win rate and a concerning 14.67% maximum drawdown. Statistical significance is nonexistent given only two trades, rendering the 0.14 Sharpe ratio and final capital of \$10,042.90 analytically meaningless. The strategy fails to generate alpha or demonstrate consistent risk-adjusted returns under current market conditions. We must reject this signal logic and recalibrate entry thresholds or filter noise before deployment. This approach is not viable for institutional capital allocation.
