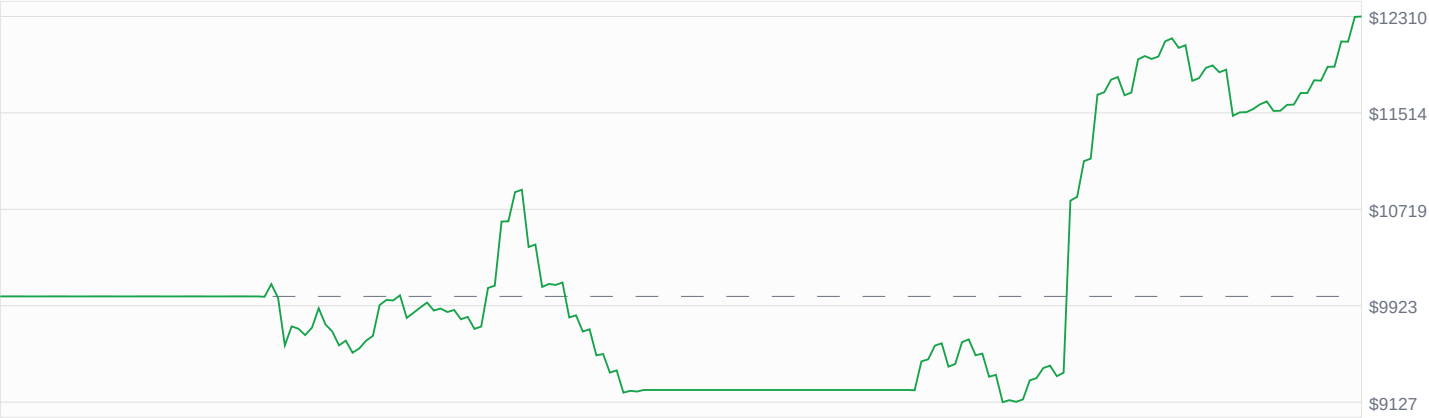

ANALYST NOTE

The EVO_GG1RSISNIP_v1422 strategy shows a 23.06% ROI on MSFT with a 1.19 Sharpe ratio, yet its statistical significance is negligible due to only two trades. A 50% win rate and 14.24% maximum drawdown indicate high volatility without sufficient edge confirmation over a meaningful sample size. The strategy likely overfit to specific price conditions, as the low trade count prevents reliable assessment of consistency or risk. We must expand the backtest window or adjust parameters to generate at least 50 trades before deploying live capital.
