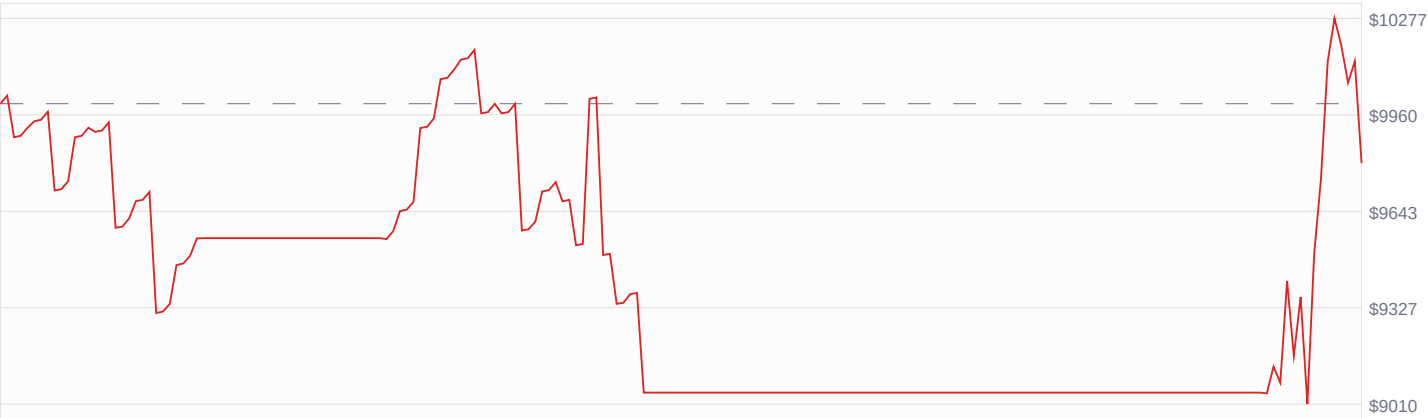

The EVO_GG1RSISNIP_v1441 strategy on VOXR failed decisively, delivering a -2.01% return and negative Sharpe ratio due to excessive losses on just three trades. With only three executions, the sample size is statistically insignificant, rendering the 33.3% win rate unreliable and the 11.32% drawdown potentially an outlier rather than a systematic flaw. The strategy lacks robustness in this environment, failing to preserve capital during the initial testing phase. Immediate action requires either pausing deployment to avoid live drawdowns or running a longer backtest with different parameters to validate signal logic.
