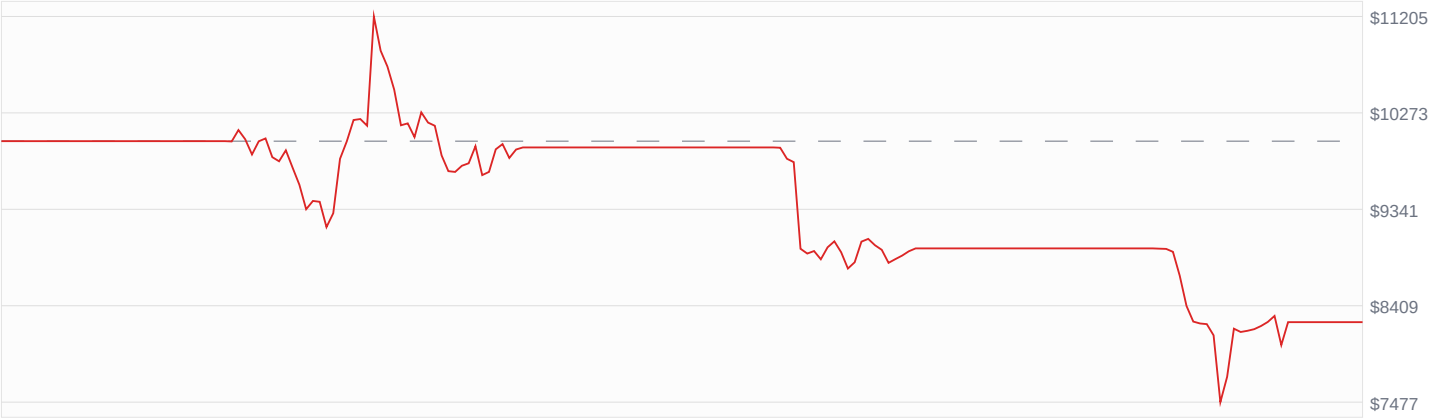

The EVO_GG1RSISNIP_v1449 backtest on META failed catastrophically with a -17.5% ROI and zero winning trades, driven by a severe 33.3% drawdown. A sample size of only three trades renders the Sharpe ratio of -0.85 statistically insignificant and untrustworthy for institutional deployment. The strategy likely suffered from overfitting to recent volatility or missed critical stop-loss triggers during the initial entries. We must immediately reduce position sizing to zero until parameters are re-optimized using a rolling window of live data.
