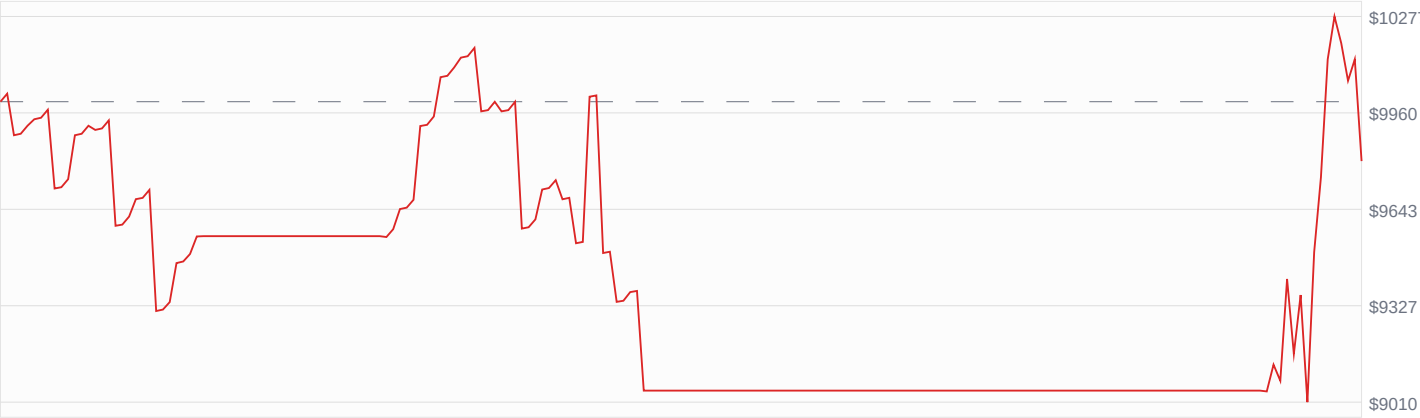

The EVO_GG1RSISNIP_v189 strategy on VOXR produced a negative ROI of -2.01% with a Sharpe ratio of -0.05, indicating a net loss of capital over the simulation period. With only three trades executed, the sample size is statistically insignificant, rendering the 33.3% win rate and 11.32% maximum drawdown unreliable metrics for predictive modeling. The strategy failed to capture meaningful alpha while exposing the portfolio to meaningful downside risk relative to its tiny trade frequency. A concrete next step involves expanding the backtest lookback period to at least 500 trades or adjusting entry filters to reduce false signal generation. Institutional deployment requires a statistically robust track record before considering any
