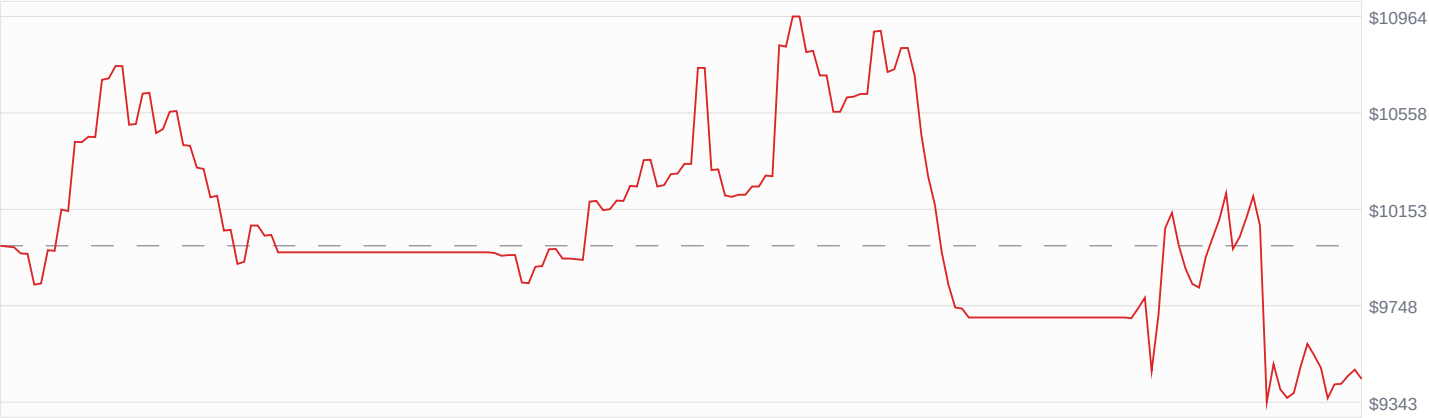

The EVO_GG1RSISNIP_v193 strategy on RDN failed entirely, recording zero profitable trades and a negative Sharpe ratio of -0.31. With only three total trades, the statistical sample is too small to draw robust conclusions about strategy viability. The maximum drawdown of 14.78% indicates significant volatility exposure without any compensating winning signals. A concrete next step is to increase the backtest lookback period to capture more market cycles and validate the signal logic. This approach will provide a statistically significant dataset before deploying capital in live markets.
