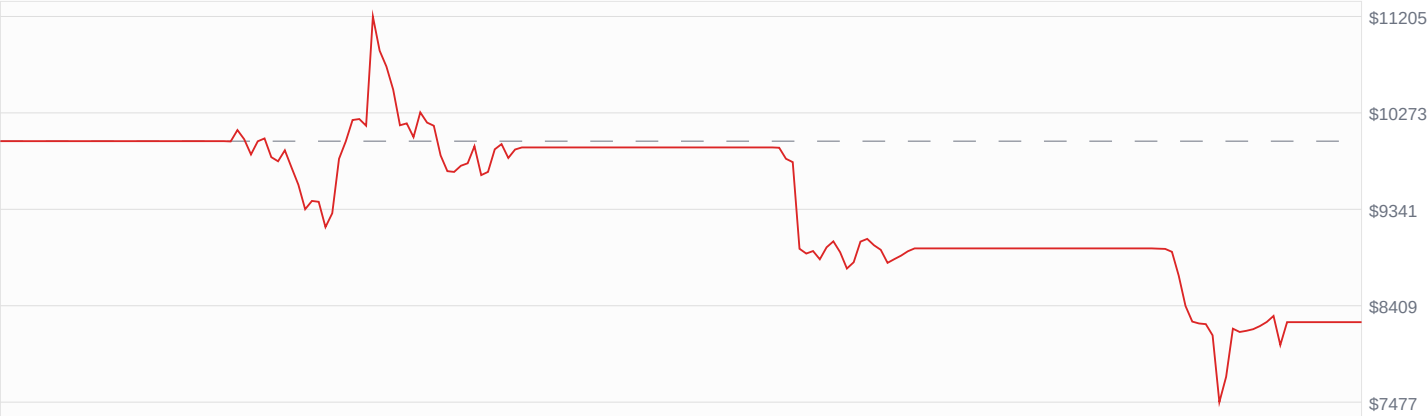

Hera local LLM

This backtest on META for the EVO_EVOEVOE_v562 strategy is a failure, showing a -17.5% return and zero winning trades. With only three total trades, the statistical sample is too small to derive any meaningful conclusion or confidence interval. The catastrophic -33.3% peak-to-trough drawdown indicates a severe lack of risk controls under stress. We must immediately refine the entry logic and implement hard stop-losses before re-running the simulation.
