The EVO_GG1RSISNIP_v249 backtest on META produced a 17.50% drawdown with zero winning trades, indicating a complete regime mismatch between the strategy logic and current volatility. A 3% trade sample size yields zero statistical confidence for any signal generation, rendering the -0.85 Sharpe ratio statistically insignificant. The extreme drawdown suggests the entry filters failed to identify the prevailing downtrend or overbought conditions. Immediate action requires a regime switch to a mean-reversion setup or a hard stop on this parameter set until volatility compresses.
