ANALYST NOTE

Hera local LLM

The backtest for RDN under the EVO_EVOEVOEVOE_v646 strategy shows a complete failure with zero winning trades and a significant loss of capital. A win rate of 0% and a negative Sharpe ratio of -0.31 indicate the entry logic is fundamentally misaligned with current market volatility. Such a small sample size of three trades provides no statistical confidence, making the 14.78% drawdown a dangerous outlier rather than a systemic risk. Immediate recalibration of entry filters and volume thresholds is required before this strategy can be considered viable. Re-running the test with stricter volatility conditions and a larger simulation horizon is the necessary next step to validate any improvements.
