The VOXR EVO_EVOEVOEVOE_v1837 backtest shows severe underperformance with a negative ROI and loss of statistical significance due to only three trades. The strategy failed to capture the asset's volatility, resulting in a sharp negative Sharpe ratio and an inability to withstand drawdowns beyond 11%. With such a narrow sample size, the observed results lack reliability and cannot be projected to live market conditions. The next step is to expand the parameter space or switch to a higher-timeframe interval to gather more data points before redeployment. This approach ensures that any future deployment is based on robust statistical evidence rather than a small, anomalous dataset.
